
## WHO CAN KEEP ON WORKING



### WHO MUST STOP WORKING



Beauty salons, massage studios, SPA salons, fitness clubs, tanning salons, other enterprises of similar services with clients personal presence (excluding services providing at a distance with the condition of delivery )

Retail stores (except pharmacies, medical and optical-ophthalmic products stores, grocery stores and convenience stores, pet supplies, mobile phone and communications stores, online stores, including those with delivery services, Do-It-Yourself goods stores and gardening goods stores)

It is forbidden to hold any sports, entertainment, public events (competitions, concerts, etc.)

Enterprises providing short-term car rental services (car sharing services)

## Until the cancellation of high availability mode, the work is suspended:

Culture and recreation parks, shopping and entertainment centers, attractions, nightclubs (discos), betting shops, sweepstakes and their betting points, cinemas, children play rooms and children entertainment centers, other entertainment and leisure facilities, bath services and showers, reception of scrap and non-ferrous metal waste from individuals.

# WHAT TO DO IF THERE IS A PERMISSION TO WORK?

In buildings, structures (premises in them), adjacent territories, and other workplaces, it is necessary to comply with the sanitary requirements (social distance and disinfection)



## Make the following decisions:



To continue working during the period of high alert.



To comply with the sanitary requirements for the organization of work of enterprises that exclude the risks of infection with COVID-19 during the high-alert mode according to the letter of the Chief State Sanitary Doctor for the Moscow Region dated 04.04.2020 No. 2978-r.



To establish the number of employees who are not transferred to a distant work mode according to their need of participation in technological and other processes necessary to ensure the functioning of such organizations.



To establish the number of employees to be transferred to a distant work mode.



Place in electronic form through the Portal of State and Municipal Services of the Moscow Region information on the number of employees (executors under civil law contracts) in respect of whom the above decisions were made.

## **Inclusion conditions - compliance with all quantitative criteria:**

- amount of tax deductions for the last 3 years in budgets of all levels: at least 300 million rubles ( $\approx 3.75$  million euros).
- headcount at least 250 people.

### or one of the qualitative criteria:

- be on the federal list of backbone enterprises
- be a large / medium-sized organization of the housing and communal complex, including a resource supplying organization (ETO, GP, etc.), a city-forming enterprise or a defense industry enterprise, a developer engaged in the construction of residential facilities with an area of at least 150 thousand square meters.

- Zero rate of import customs duty is established for a number of goods to be determined by the Government of the Russian Federation, including medicines and medical devices
- Distance trading of over-the-counter medicines and medical devices is allowed
- Mechanism is introduced for subsidizing% on loans for trade enterprises received for the formation of stocks of food and essential goods
- The "third excess" rule is temporarily suspended during government procurement of medicines and medical devices according to the list of goods determined by the Government of the Russian Federation
- Measures are introduced to financially support transport organizations affected by the deterioration of the situation, including compensation for losses.
- The extension of labor permits for foreign workers is ensured.
- The time for notifying employees is reduced to 2 weeks due to a possible shutdown of the enterprise

# **MOSCOW REGION SME SUPPORT MEASURES**

### **Moscow Region Microfinance Fund:**

- Restructuring of previously issued microloans until September 30, 2020
- Microloans at a rate of 6% per annum
- Providing preferential microloans in the amount of 5 million rubles. (≈ 62.2 thousand euros) for 3 years with maturity at the end of the term for the production of goods (works, services) used to prevent and eliminate emergency situations

### **Moscow Region Industrial Development Fund::**

• Concessional loans from 20 to 150 million rubles are provided. (from ≈ 250 thousand euros to ≈ 1.86 million euros) from 1 to 5%

### **Moscow Region Guarantee Fund:**

- Guarantee cost reduced to 0.75% in priority sectors
- Extension of the term for the submission of loan guarantees to 10 years
- Organization of interaction with major banks and development of joint support programs

# MOSCOW REGION SME SUPPORT MEASURES

## Partial compensation of expenses:

- for the purchase of equipment up to 50% of costs, but not more than 10 million rubles ( $\approx$  125 thousand euros), and for the production of goods used to prevent and eliminate emergency situations (masks) up to 80%, but not more than 30 million rubles ( $\approx$  373 thousand euros).
- partial compensation of the first installment (advance) upon conclusion of an equipment leasing agreement up to 70% of the advance, but not more than 5 million rubles (≈ 62.2 thousand euros).
- partial reimbursement of expenses of socially oriented SMEs (social services for citizens, healthcare, conducting classes in children's clubs, sections, studios, production of medical equipment, prosthetic and orthopedic products, the provision of educational services) up to 85%, but not more than 2 million rubles (≈ 25 thousand euros), if it is a nursery for children under the age of 3 years, no more than 3 million rubles (≈ 37.3 thousand euros).
- partial reimbursement of costs to SMEs operating in the field of physical education and sports up to 50%, but not more than 10 million for engineering surveys, design documentation, repairs, engineering infrastructure, equipment purchase.

# MOSCOW REGION SME SUPPORT MEASURES

- Granting to tenants in the most affected sectors of state and municipal property until 01.10.2020 a deferral of payment of rental payments with its payment in equal installments during 2021–2022
- Exemption from tax on property of organizations and land tax from 03/01/2020 to 01/01/2020 for owners of real estate (shopping centers, retail outlets, catering and consumer services) subject to lower rental rates for tenants who have suspended their activities due to the introduction of high availability
- An increase in the share of purchases among small and medium-sized enterprises, socially oriented non-profit organizations carried out in accordance with Federal Law of 05.04.2013 No. 44-FZ, from 25% to 30%
- Advance payments up to 30% for small and medium enterprises by state and municipal customers
- Introduction for small trading formats of a 6-month deferral of payments under contracts for the placement of non-stationary trading objects (NTOs), extension of the layout of non-stationary trading objects (NTOs) for 12 months
- Granting to tourism industry entities of the Moscow region specializing in promoting tourism in municipalities of the Moscow region
- Creation of the "Made in Moscow Region" trademark
